

What is CalAIM

Waiver program and multi-year initiative by DHCS to improve the quality of life and health outcomes of our population by implementing broad delivery system, program and payment reform across the Medi-Cal program.


DHCS CalAIM Goals

- Identify and manage member risk and need through Whole Person Care approaches and addressing Social Determinants of Health;
- 2. Move Medi-Cal to a more consistent and seamless system by reducing complexity and increasing flexibility; and
- 3. Improve quality outcomes and drive delivery system transformation through value-based initiatives, modernization of systems and payment reform.

CalAIM Target Population

- High utilizers (top 1–5%) of care
- Individuals at risk for institutionalization
 - Individuals with Serious Mental Illness
 - Children with Serious Emotional Disturbance
 - Individuals eligible for long-term care (LTC)
- Those with frequent hospital or emergency room (ER) admissions
- Nursing facility residents who want to transition to the community
- Individuals transitioning from incarceration
- Individuals suffering from chronic **homelessness** or who are at risk of becoming homeless.


